



## Costco Wholesale Corporation Reports July Sales Results

ISSAQUAH, Wash., Aug. 07, 2019 (GLOBE NEWSWIRE) -- Costco Wholesale Corporation ("Costco" or the "Company") (Nasdaq: COST) today reported net sales of \$11.43 billion for the retail month of July, the four weeks ended August 4, 2019, an increase of 7.9 percent from \$10.59 billion last year.

For the forty-eight weeks ended August 4, 2019, the Company reported net sales of \$137.56 billion, an increase of 8.0 percent from \$127.40 billion during the similar period last year.

Costco also operates e-commerce sites in the U.S., Canada, the United Kingdom, Mexico, Korea, and Taiwan.
