



COSTCO WHOLESALE CORPORATION REPORTS MARCH SALES RESULTS

ISSAQUAH, Wash., April 08, 2020 (GLOBE NEWSWIRE) -- Costco Wholesale Corporation ("Costco" or the "Company") (Nasdaq: COST) today reported net sales of \$15.49 billion for the retail month of March, the five weeks ended April 5, 2020, an increase of 11.7 percent from \$13.87 billion last year.

For the thirty-one weeks ended April 5, 2020, the Company reported net sales of \$96.25 billion, an increase of 9.0 percent from \$88.29 billion during the similar period last year.

Costco also operates e-commerce sites in the U.S., Canada, the United Kingdom, Mexico, Korea, Taiwan, Japan, and Australia.
